Letter from the Organization

To the Community We Serve,

The year 2021 was tough for many of us. The terrible economic, social, and health effects of COVID-19 continued well into the year. But thanks to advances in public health and other science, we began to rebuild our connections with each other.

Good and bad things happened in 2021. Within our smaller world of HAA, the team met challenges and leveraged opportunities. It was certainly a year of change, rolling with the punches, making the best of tough situations, and getting back on our feet with vigor and resolve after the worst pandemic year. The following is intended to share with the community what the HAA team is most proud of during 2021.

The Disaster Services Division of HAA, launched after Hurricane Harvey, performs two critical tasks: acting as the go-to resource for the arts community on disaster-related issues and advocating for the region's existing emergency management system to fairly include the arts, as they do any other sector. Both objectives take constant effort. HAA strategically does not seek to replace any public or private service related to resilience and recovery. Instead, HAA identifies the gaps in current service and fills them, with the goal of permanent change in how the arts are protected before and after disasters by our community's designated emergency management.

In 2021, HAA's Disaster Services Division continued its activation to respond to the COVID-19 crisis. Meeting regularly with a collaboration of arts service organizations and county- and country-wide disaster response collectives, HAA delivered critical recovery information to the community about medical supplies for performances, vaccines, and economic support such as grants and loans. The organization hosted town halls to allow the arts community to find social cohesion in a time of isolation—an event series that continues today. In 2021, HAA completed the distribution of nearly \$400,000 in emergency stipends for artists and other arts professionals facing dire personal hardship (most of those funds were distributed in 2020). During the arctic blast of February 2021, HAA reactivated the fund, requesting donations and distributing funds, though few artists requested assistance following the freeze.

Notably, Harris County asked HAA to join their Recovery Support Function Lead as the lead agency for Natural and Cultural Resource Recovery. Through our work in this position, we have created a permanent place for HAA within the county recovery structure for all future disasters—and when Hurricane Nicholas hit in September 2021, we were among six agencies who decided whether to activate the county's recovery system. The program team joined the Fort Bend County Long-Term Recovery Group to expand our formal roles into two counties. The team released the Arts and Disaster in the Houston Area Report, a historic event and a first in the nation, after the report was temporarily put on hold so the team could focus on its COVID-19 response. In 2021, the team launched a county advocacy campaign for \$30 million in ARPA funds, though ultimately—and with grave disappointment—HAA failed to achieve such an audacious attempt.

The Grants Division serviced 354 eligible applicants in 2021. HAA's competitive peerreview process resulted in 256 grants through five grant categories, totaling \$12.5M. HAA continues to post a transparent report of its annual grants process—about its workshops, panelists, and more—in online dashboards at haatx.com. HAA has made aggressive improvements to its grants over the last four years. To address internal and external racial and other inequities, we improved our communications with arts community members who we have not historically reached; we expanded the diversity of the arts experts who read and score our grants; and intentionally adjusted organizational leadership to better mirror Houston's demographics, as reported in HAA's board of directors online dashboard. We partner with Houston City Council Member offices to distribute grants notices, and we host live, online chats through Instagram and Facebook. We've made grants information sessions available 24 hours per day through online recordings. In 2021, we implemented a drastic change to meet the needs of the arts community in response to the pandemic's depression of Hotel Occupancy Tax (HOT) receipts, the funding source for the city's arts grants that HAA administrates. Specifically, we extended 2020 contracts using a portion of the 2021 HOT receipts to ensure those individuals could complete the critical work they do for the community and our visitors, and we administrated new grants using another portion of the 2021 HOT receipts to ensure those seeking funds still had a place to go to compete for their work. HAA also heeded calls from the community to address the instability caused by the pandemic's impact on the economy and pivoted to ensure all individual artist grants and festival grants were made from cash-in-hand at HAA and not based on projected HOT (the funding model for the last 30 years).

The Civic Art Division grew dramatically in 2021, with a nearly all-new team, director, project managers, and administrative experts, as well as a strategic reorganization of duties. The division created a systems manager position to better create replicable, high-quality processes that improved the quality of experience for applicants and panelists, kept projects on track, and built more art for the community. A new finance administrator position helped the organization navigate the complex financial spending and income required of the program as it managed project phases that called for phased invoicing to the city and phased payouts to artists based on project milestones. The team handled a record-setting 50 projects for the City of Houston in 2021, totaling \$666,052. The City's annual report on the Civic Art program details each project and its key characteristics. Civic Art serves the occasional private client. In 2021, the Texans hired HAA to help them engage artists to create a handful of murals.

HAA began to house the BIPOC Arts Network and Fund (BANF), providing office space, financial management, and other basic services, while BANF designed its own independent decision-making structures. HAA is honored to contribute to this critical investment by local and national philanthropies.

HAA experienced a decent amount of turnover, growth, and challenge in 2021. But every challenge is just an opportunity for improvement, risk-taking, and better service to the City of Houston and its arts community. I hope we made everyone proud—and hope we always do.

HAA continues to post public information about grants, grantees, panelists, and other efforts in its online dashboards. These are available at haatx.com.
